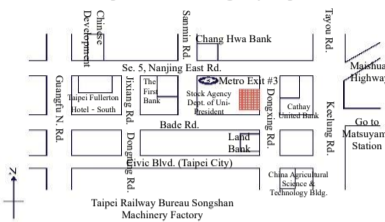
- (I) On May 20, 2026 (Wednesday) at 9:00 AM (Registration for shareholders begins at 08:30 AM at the same location), the 2026 Annual Shareholders' Meeting will be held at Einstein Hall [GIS HSP Convention Center] located at No. 1, Gongye E. 2nd Rd., East Dist., Hsinchu City, Taiwan, Taiwan (R.O.C.) - Hsinchu Science Park. The main agenda of the meeting includes: (I) Company Reports: 1. Operating Report for 2025. 2. Audit committee's Audit Report for 2025. 3. Report on employee remuneration and director remuneration distribution for 2025. 4. Report on cash dividends and dividend distributions from earnings and additional paid-in capital for 2025. (II) Proposals for Ratification: 1. Operating report and financial statements for 2025. 2. Report on earnings distributions for 2025. (III) Election: Election of the Company's 17<sup>th</sup>-term directors. (IV) Other Proposals: Proposal to release non-compete restrictions on the Company's newly elected directors and their representatives. (V) Extempore motion.
- (II) Dividend distribution as resolved by the meeting of the Board:  
Cash dividends from profit distribution: The cash dividend shall be distributed at NT \$2.2 per share, amounting to NT \$354,373,017. The Board of Directors is authorized to make a pro rata distribution according to the number of shares held by the shareholders as recorded in the shareholder register on the ex-dividend date. The total amount of cash dividends paid to each shareholder shall be rounded to NT dollars and the fractional part less than NT 1 dollar will not be counted.
- (III) Seven directors (including three independent directors) were elected under a candidate nomination system at this shareholders' meeting. The list of director candidates includes Chen, Cheng-Hsin, acting as the representatives of Junpeng Investment Co., Ltd., Frank, Liang, acting as the representatives of C SUN, Rong-Liang Chen, and Tony, Tsai. The list of independent director candidates includes Yin, Chung-En, Ho, Jung-Shu and Tan, Chih-Chung. - (IV) As per Article 209 of the Company Act, the non-competition restrictions on the directors during their terms of office shall be canceled. For more information on this topic, please refer to Paragraph X for further inquiry.
- (V) In accordance with Article 165 of the Company Act, the transfer of shares shall be suspended from Mar. 22, till May 20, 2026.
- (VI) In addition to the announcement, a special letter will be delivered along with a sign-in card and a copy of power of attorney for your presence the general meeting of shareholders. Where you attend the meeting in person, please fill in the sign-in card on the **Second Page** and arrive at the meeting venue with it on the date of the meeting.
